1.	The travel document must be valid for a minimum of 3 months from the date of departure from the Schengen area. Issued within the previous 10 years and have at least 2 blank pages. Provide previous old/canceled passports – including any valid visas for Schengen or USA/UK.		
2.	<u>Schengen Visa Application.</u> Printed and signed by the applicant, along with one passport-style photograph (max. 6 months old, on a white background, measuring 3.5 x 4.5 cm.)		
3.	Online application form https://visa.government.is/ . Printed and signed by the applicant.		
4.	Travel medical insurance (insurance card is NOT sufficient) valid for all Schengen countries. The insurance must cover the applicant for at least 30,000 USD (30,000 EUR), for all risks e.g., accident, illness, medical emergency evacuation etc. The policy must clearly specify the period of validity, the coverage area and the entire duration of the trip including the date of arrival and departure.		
5.	Proof of Transportation - Flight reservation of return or roundtrip ticket. If the applicant is traveling to several Schengen countries, proof of intra-Schengen flight reservations, train itinerary or car rental. Please note that the tickets do not have to be paid, the reservations suffice. Include a travel itinerary specifying travel within the Schengen area.		
6.	Proof of accommodation – Hotel reservations or other confirmed accommodations, stating name, address and telephone number of the lodging. If you intend to stay with a family member or a friend, proof of sponsorship and/or private accommodation from the host.

8.	 If employed, you must provide a letter from your employer indicating the start date of your employment and your job title. Dependent visa holders (H4, L2 or F2) must provide a copy of the Employment Authorization Document (EAD). If self-employed, you must provide your latest tax returns (Form 1040) and business registration. If student, please provide proof of enrollment, a valid F or M visa and a valid I-20 form with a signed travel endorsement within the last 12 months. If retiree, you must provide proof of Supplemental Security Income (SSI) or retirement savings or other financial support. If unemployed, you must provide proof of unemployment benefits or other financial support. 		
9.	Proof of sufficient funds for the intended stay U.S. bank statements or U.S. credit card statements in your name from the previous consecutive 3 months. The statements must show that you - during the entire trip - have \$30 per day for staying in a hotel or \$15 per day if the expenses connected with the stay are borne by a third party.		
10.	 In case of minors (<18 years) traveling: If the minor is traveling with only one parent, written consent certified by a public notary of the other parent or guardian, except in cases of a parent having sole custody or guardianship of the minor. If the minor travels alone (without parents or guardian), written consent from both parents or guardian having custody of the minor.
